1 VS-4E 4X4 ビデオ オーディオ スイッチャーについて

VS-4E 4 X4 ビデオ オーディオ スイッチャーは、BNC コネクタ使用のコンポジットビデオ信号と RCA コネクタ使用のステレオ音声信号用の高品質なメカニカルスイッチャーです。

本機はコンパクトなデスクトップサイズで、映像と音声を独立に切換える用途向けに設計されております。

VS-4E は、1 対 1 のビデオスイッチングと 1 対 1 の音声スイッチングのみを提供するものです。ひとつの信号を同時に複数の出力に分配することは出来ません。

高品質のスイッチング部品の使用と注意深く設計された回路により、各入力信号間での卓越したアイソレーション性能を実現した VS-4E は、広帯域となる高解像度の映像信号用として最適です。

電源不要の設計は、各種規格との適合が要求される用途においても有利となります。

選択されていない入力信号は75Ωの抵抗で終端されます。




図1: VS-4E 4X4 ビデオ オーディオ スイッチャー

 - iii) Repair or attempted repair by anyone not authorized by Kramer
 - Any shipment of the product (claims must be presented to the carrier)
 - v) Removal or installation of the product
 - vi) Any other cause, which does not relate to a product defect
 - vii) Cartons, equipment endosures, cables or accessories used in conjunction with the product

WHAT WE WILL PAY FOR AND WHAT WE WILL NOT PAY FOR
